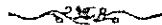

PREAMBLE.



Being desirous of assisting towards the establishment and maintenance of relations of friendly intimacy among those who are of Scottish birth or extraction, and of keeping alive in them an interest in Scottish customs, we do form ourselves into a Society, bearing the designation of "The South Australian Caledonian Society," whose chief objects shall be to bring together Scotchmen in South Australia for their mutual benefit, for the encouragement and practice of the games, and preservation of the customs and manners of Scotland, and the promotion of a taste for her language and literature; to encourage the settlement of natives of Scotland in South Australia, and to disseminate information regarding this colony in Scotland, and to assist any who may be in difficulty or distress, as far as may seem expedient and the resources of the Society permit; to establish and support a reading or club room with library for the use of members; and for the establishment of a fund to carry out any national or philanthropic objects.

ANNUAL REPORT.

TO THE MEMBERS

OF THE

❖ S. A. Caledonian Society. ❖

Gentlemen,

Once more the time has come round when the duty devolves upon your executive of presenting to you the Annual Report and Balance Sheet for the year ending 31st July, 1888.

In presenting this report, the seventh in the history of the Society, it is with very different feelings to those experienced by the executive this time last year; at that date, the Society was at the very worst financial stage it had ever reached, and in some quarters grave doubts were expressed as to whether the Society would ever be able to emerge from the "Slough of Despond" it had fallen into.

Yet, "hope springs eternal in the human breast!" and with the characteristic pluck and perseverance of the Scottish race, we have been enabled so far to accomplish a great deal towards the goal we had in view, viz.—The liquidation of the large overdraft which was crushing us down and nullifying our efforts towards advancement.

Chief.

In February of this year, our honored Chief, the Hon. DAVID MURRAY, M.L.C., found it necessary to leave the colony on a visit to the mother country, and a deputation of the Society waited upon him, and, while expressing

regret at losing his valuable services, wished him a safe voyage and a speedy return.

In looking for a successor to fill the chair for the balance of the year, the name of ALOYSIUS MACDONALD, Esq. was mentioned, and on a representative deputation waiting upon that gentleman and requesting his acceptance of the position, he at once consented to act.

It is almost needless to state how fully and faithfully our Chief has merited the confidence the Society had in him in asking him to take the office, and the Society is to be congratulated on having again obtained his services as Chief for the year we are now entering upon.

Secretary.

Another change has taken place amongst the officers of the Society, as in December last MR. D. MORTON TWEEDIE found it necessary to relinquish the duties of Honorary Secretary, owing to the pressure of his own private business, and the present occupant of the office, MR. EDWARD DRUMMOND, kindly consented to take the reins; and considering that the Annual Sports were about to be held, this was rather an onerous task, but your executive have every reason to be satisfied with the way in which the duties have been carried out.

In this connection, it may not be out of place to mention the valuable assistance rendered to the Secretary during the last few months by Messrs. NICHOLSON, EWEN, MCKINNON, and RAYNBIRD and J. DRUMMOND.

Yet one more change has taken place in the *personnel* of the executive—a change which all of us most deeply deplore—in the lamented death of SIR ROBERT DALRYMPLE ROSS, M.P., Speaker of the House of Assembly, for many years an ardent supporter and distinguished member of the Society. A man not only respected through the length and breadth of the colony, but one whom our beloved Queen considered worthy of high honors.

MR. W. T. McLEAN was unanimously elected to fill the vacancy thus created in the list of Chieftains, while MR. J. H. D. DAVIDSON was chosen as Director in place of MR. McLEAN.

Financial.

We now come to the most vital portion of our report affecting the well-being of this Society :—

On the 1st August last year, we find that our overdraft at the Bank of Australasia stood at £207 17s. 1d. ; to-day the amount at our debit is £65 19s.

These figures speak for themselves, and show that a very strong effort has been made during the past year to wipe off the deficit.

While, however, there is great cause for congratulation on this result, we would point out to the Society that the reduction is not of the legitimate character we would have liked to have seen.

While our ordinary income, arising from subscriptions, sub letting of hall, and receipts from Social Committee, amounts to £227 2s., our ordinary expenditure during the same period amounts to £210 18s. 6d. ; so that the balance of income over expenditure, by means of which we have been enabled to reduce the overdraft, has come from the general public by means of concerts, and by donations.

It will be also observed from the Balance Sheet now before you, that, had it not been for the donations received towards the same, the Annual Sports would have shown an actual loss.

There is no denying the fact that to make the Society a success it should be supported entirely by subscriptions of the members, and any extraneous receipts ought to be capitalised for future use.

We are constrained to impress this most strongly upon the members, as reference to the Roll-Book shows that there are still large arrears of subscriptions outstanding ; and, during the year, special efforts have been made by circular and otherwise to collect same, but, so far, the result has not been encouraging.

Membership.

During the year, twenty-seven new members have joined the Society ; five have resigned, and two have died ; in addition to this, the Roll has been purged of many names who were irretrievably behind in their subscriptions.

Concerts and Tableaux.

During the year, three Concerts have been given under the auspices of the Society, and each of them was an unqualified success.

The Tableaux given in the Albert Hall on the 20th June and 5th July, depicting the "RELIEF OF LUCKNOW," were quite a novelty, and were heartily appreciated by the public. Your executive would take this opportunity of tendering their thanks to the ladies and members of the Society who so kindly offered their services to take the positions required for the proper rendering of the numerous scenes; to CAPTAIN DAVIDSON, as General Manager; to the Company of Militia under his command; and last but not least, to MR. D. NICHOLSON, who so ably officiated as Stage Manager.

Our Concert in the Town Hall in November was considered worthy of repetition, and MR. CONIGRAVE, Secretary to the Jubilee Exhibition waited on the then Secretary, MR. TWEEDIE, and requested him to repeat the same in the Exhibition Building. This was arranged, and a very successful Concert was the result.

In giving these two Concerts we were under great obligations to the Goodwood Choir under MR. McLENNAN, conductor, for their valuable assistance.

Sports.

Our Annual Sports were held on Easter Monday, and as usual were a great success so far as the management and Sports were concerned; unfortunately, however, the attendance was far short of what we would have liked, and should we decide to hold Sports next year it will be a matter for consideration later on whether it would not be better to alter the date to, say, New Year's Day, as it is undeniable that we lose a great number of the public owing to the counter-attractions of Onkaparinga, &c., on Easter Monday.

The Social Committee have done good work during the year, having held six Socials irrespective of the usual Saturday evenings, which are very much appreciated by the younger members of the Society.

MR. J. D. BRUCE as Secretary to the above Committee has shown himself to be very energetic.

An Athletic Club has been formed for some months past, and under the conductorship of MR. D. BELL is very well patronized. We believe that a Debating Society will be formed shortly so that members will be able to exercise their brains as well as their muscles.

MR. D. EUNSON has also undertaken the conductorship of a Singing Class, and so far there is every reason to believe that in a short time he will be able to turn out a very efficient choir, and we heartily wish him every success.

We have also to tender our acknowledgments to STAFF-SERGEANT HARRISON JAMES, late of 79th Highlanders, for the lecture delivered by him on the ever-interesting subject of the Indian Mutiny.

Life Members.

During the year two gentlemen have availed themselves of the new rule providing for the admission of Life Members—MESSRS. PETER AND J. DOIG of Beltana. In addition to this, at a recent meeting it was proposed and carried unanimously, that in consideration of the services rendered from time to time by MESSRS. EUNSON, PATERSON AND TWEEDDALE in assisting at our concerts they should be admitted as Life Members, and at the same meeting the REV. J. MACBEAN was accorded a similar privilege.

And now, in conclusion, your executive are by no means desirous of adopting a policy of "rest and be thankful," we must be up and doing, as we are not yet out of the wood, we must get our balance on the right side, and if this can be done amongst ourselves without appealing to the public so often, so much the better.

Just one word regarding the objects and aims of the Society. We do not profess to be a benefit society from a pecuniary point of view, although many Scotchmen have reason to thank the Society, not only for having rendered them assistance, but also for having been the means of their obtaining employment in the colony, and there is scarcely a week passes without the Secretary being appealed to in this direction.

What we aim at doing, and so far we have done, is to afford a place of meeting for Scotchmen, new arrivals in the colony, possibly without friends or acquaintances, where they can spend a pleasant evening conversing with their "brither Scots" or perusing the newspapers, &c., of the day, and where our own members too who may be in lodgings can spend a profitable evening.

Since the inauguration of this Society some eight years ago, many lasting friendships have been cemented through the *medium* of the S.A. Caledonian Society, and many young men newly from the "LAND O' CAKES" have expressed their appreciation of the benefits conferred on them by the Society.

In closing this somewhat lengthy report your executive look forward to a year of continued and zealous effort by every individual member of the Society, so that when our next annual meeting is held we may be in a much stronger position numerically and financially than we are to-day.

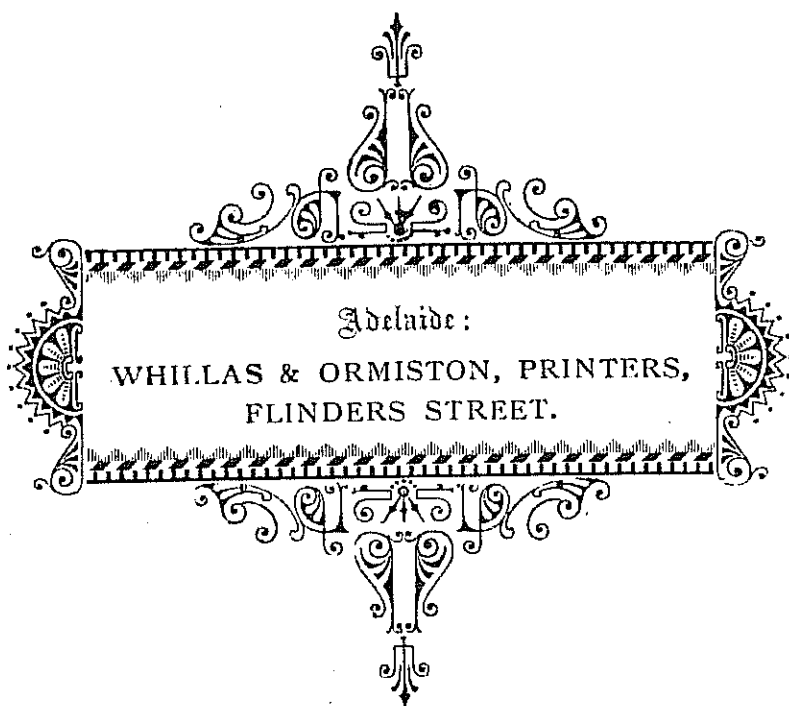
